

## NOTICE MEFF 05/2023

In relation to notice 24/22 on the new functionality of the retail client flag, MEFF announces that this functionality will be available in the test environment as of 23rd March.

Due to this change in the **test environment**, as of the above mentioned 23rd March:

- New versions of the FIX, trading and market data APIs T5.15 and M5.15 that will incorporate this retail client flag will be available for use. Migration to these new API versions will not be mandatory and the current versions will remain available.
- The Market Data binary information, as well as that for Replay and Recovery connections, will only be available in the new B1.5 version.
- The trading binary protocol API (OES) will not be affected by this change. However, a new version B1.5 will be available, which does not differ from the previous versions.

Members' systems connecting to the Market Data binary API **must be prepared** to receive the B1.5 information, regardless of their use of the new functionality.

- Only MEFFStation and MEFFServer version 11.26.00 or higher will be able to connect to the test environment from 23 March.

## In production environment:

- Version 11.26.00 of MEFFStation and MEFFServer incorporates the changes due to the Retail Client Flag functionality (whose activation will be notified soon) and the new security requirements for MEFF passwords. This version will be available for download from 30 March.
- The terminals version 11.26.00 includes changes in the TORDERS, TTRADES, TACCOUNTS and TLOGORDERS trade files, with the addition of a new "RetailCIFlag" field in each of them.

The automatic installation of terminals will take place the week of 17 April and the SFTP downloadable files will include these changes from the week of 22 May.
