Reduced trading hours of the xRolling FX segment

MEFF announces a reduction in trading hours for the xRolling FX segment as of **7 July**.

To reflect the mentioned changes, the following Circular has been modified, which is available to members on the MEFF website.

With this reduction, trading hours will be as follows:

- Start of Opening Auction: 7:55 a.m.
- Start of Trading and registration of Pre-Agreed Trades: 8:00 a.m.
- Closing of Trading and registration of Pre-Agreed Trades: 22:00 hours
- Publication of closing prices: 22:03 hours
- Market close: 22:05 hours.
- Obtaining trading files: from 23:45 hours (if a terminal receives only trading information, the files will be available at 22:10 hours).

Calculation of closing prices:

Closing Price for the xRollingFX Futures is obtained from the average prices ranges available in the Spot Market between 21:59 and 22:00 CET.

With this average ranges, closing prices are going to be obtained taking into account that must be non-arbitrable prices, this means that any cross price has to be equal to the inferred crossing prices.

As there are many combinations of non-arbitrable prices, it will be chosen the ones with the lowest difference with the mid-price.
