Connectivity test – BME Group's Back-up Data Center migration

As previously communicated in September 2024, BME is in the process of migrating its Back-up data center from its current location at Plaza de la Lealtad to the Equinix MD6 facility in Alcobendas. This strategic move aligns with our goal of meeting the performance and security standards of the SIX Group.

All **BME managed data lines** used to connect with clients have already been successfully relocated to the new site. There are few **client-managed lines** which are still on the migration process.

On the BME Group side, the necessary infrastructure work has been largely completed. As part of the project completion we are pleased to inform you that on 20th September 2025, BME will offer all clients the opportunity to perform **final connectivity testing**. Detailed information about the testing process is provided at the end of this notice.

For Fixed Income market members, this change is being coordinated with the migration of the production site for those markets. Therefore, on this case, the connectivity test regarding the Back-up data center migration can be replaced by the test planned for the market migration.

Following the successful completion of these tests, BME plans to decommission the Plaza de la Lealtad site as a connectivity hub.

Details regarding the Clients Connections Failover Test

A Failover test is focused solely on client connections.

During this test, the BME Network Team will disable all clients connections in Las Rozas, affecting both managed and unmanaged lines. Clients will be rerouted exclusively through the MD6 data center.

Following internal validation, a testing window will be open during which clients are encouraged to perform their own connectivity and functionality checks. Clients are encouraged to document any issues encountered and report them to our network team for analysis.

Connections in Las Rozas will be restored after the testing.

Concrete timetable will be provided at the beginning of September.
