Equinox Project Update



6 October 2025



SIX Group AG ("SIX") with SIX Swiss Exchange AG ("SSX") and Bolsas y Mercados Españoles ("BME") are pleased to confirm that the Equinox project is continuing to progress according to the announced plan. The implementation will be carried out in three stages:

- Stage 1 Equities and Equity like Products
- Stage 2 Fixed Income and Structured Products
- Stage 3 Derivative Products

A detailed timeline for the new Equinox platform will be shared in due course. The key milestones for the first stage are as follows:

- Q1 2026: First version of the specifications will be published
- Q2 2026: Updated specifications will be published
- Q3 2026: First version of the Member test environment will be available
- O4 2026: Conformance test will be available
- First half of 2027: Equinox platform will go live for Equities and Equity-like products

Please note that all current interfaces (STI, OTI, QTI, IMI, BME current FIX and binary interfaces) will be replaced in stages by new interfaces used by the Equinox platform. While the future specifications will not replicate the current Aquis interfaces, they will serve as the starting point for development. Additionally, the SIX MDDX (Multi Dimensional Data FluX) interface will also undergo changes. However, these changes will be more limited in scope, as the MDDX standard must remain compatible with other markets that are not yet transitioning to the Equinox platform.

We would also like to remind you that the SSX and BME Equity Member Sections contains a repository with all materials relevant for the Equinox project. This currently includes:

- A FAQ document, updated quarterly
- Presentations
- All messages sent to date
