MEFF adapts its Block trade Portal to the security standards of the SIX Group

MEFF upgrades the Block Trade Portal (Meff Trade Entry) to comply with SIX Group security standards

As announced in Notice 50/25, and in line with MEFF's commitment to meeting the performance and security standards of SIX Group, the Block Trade Portal (Meff Trade Entry) has been updated to comply with the newly established requirements.

Starting Monday, **26 January, the old access system will be permanently disabled**. From that date on, access will only be possible through the two-factor authentication system at the following link:

<https://trading.bolsasymercados.es/brokerMeff>

The new portal does not introduce any functional changes, and each user's current trader database will remain intact.

The main change lies in the access procedure. From now on, **member-user identification must be carried out using an email address associated with the operator**. Additionally, as a security enhancement, the FUTURAE application must be installed to enable the **two-factor authentication system** (the same app is required for both the training and production environments).

A single member-user may be linked to several operators, who may be connected simultaneously. They will share all user information and the trader database; however, each operator must log in using their own email address and complete two-factor authentication through their personal FUTURAE app.

Since November, operators have been able to register in the new portal. If you have not yet completed the registration, you may do so by filling in the attached user registration form and sending it to meffmarketservices@grupobme.es

For more details on the new access procedure, please refer to **Annex I**, which provides step-by-step instructions.

All users currently registered who have not requested registration in the new system by **1 March 2026 will be removed** from the platform and will lose all trader database information associated with their user profile, with no possibility of recovery.

4. Once the code is entered, a QR code will appear. This must be scanned using the FUTURAE app, which should be installed beforehand. Select "SCAN QR" in the app to proceed.
