Withdrawal from Trading of IBEX Sector Index Futures, Micro IBEX Futures and 10-Year Notional Bond Futures

MEFF hereby informs its Members that, in coordination with BME CLEARING and following a review of trading activity trends and market participant demand, it has been decided to discontinue the offering of certain contracts and underlyings currently available for trading and clearing.

The contracts that will no longer be available are the following:

- IBEX sector index futures: IBEX Banks Futures and IBEX Energy Futures.
- Micro IBEX Futures, corresponding to the IBEX index future with a 0.1 multiplier.
- 10-Year Notional Bond Futures.

These contracts are scheduled to be withdrawn from the trading system on **1 October 2026**. However, as from the date of this communication, no new contract will be listed in respect of these products.

Accordingly, the Circulars and other regulatory provisions containing references to these contracts will be amended and updated to reflect this decision. MEFF will inform Market Members as soon as the corresponding regulations have been published and made available on its website.

In addition, the Circulars relating to Listed Contracts and Closing Prices incorporate certain technical and regulatory amendments of a preparatory nature for the future introduction of cash-settled european-style Stock Options on European underlyings. These contracts are expected to become available for trading during the course of this year, and the market will be informed accordingly. Therefore, the provisions relating to these new contracts and European underlyings will not become applicable until the effective date on which trading in such contracts commences.

MEFF also informs Members that, within the Member Testing Environment, there are open positions in some of the contracts that will be discontinued. In order to proceed with the removal of these contracts from that environment, the affected positions will be closed during the month of October.
