NATURGY S.A. – Adjustment to Futures & Options Contracts

The Spanish Securities Market Commission (CNMV), in an "Other Relevant Information" published on March 26, informs about the request for the authorization in relation to the voluntary and partial takeover bid for NATURGY ENERGY GROUP, S.A. (Naturgy) of its own shares.

The offer will be made on 9,08% of the shares of Naturgy, at a price of 26.50 euros per share in cash.

MEFF informs that new maturities of Naturgy futures and options shall not be opened until the end of the takeover.

According to sections 4.7.1.9, 5.7.1.9 and 6.6.9 of the General Conditions of the Financial Derivatives Segment, MEFF will ask to the Supervision and Surveillance Commission, once the corresponding prospesctus has been published, to determine the result of the NATURGY takeover bid that must be fulfilled with the adjustment of the futures and options contracts.

In the case of settlement of the open position at theoretical value, MEFF will take as a reference the parameters set in Annex 1.
